Nevertheless, Mrs. Willison has succeeded in showing that defendant negligently breached a duty owed to Mrs. Willison and caused her injury. The question of the amount of damages she has incurred remains to be determined at the trial of the remaining issues. By its third issue, defendant contends that the trial court erred in instructing the jury on contributory negligence, but in failing to submit contributory negligence on the part of Mrs. Willison as an issue to be resolved by the jury. This Court has often held that when contributory negligence has been charged,

the trial judge should submit to the jury the issue of contributory negligence in general, not as to any individual party. Lindsay v. Winfree, 284 N.C. 81, 199 S.E.2d 447 (1973).
